澳門大學研究生會 第1/2020 號選舉委員會通告

接受第十五屆澳門大學研究生會領導機關選舉報名

根據《澳門大學研究生會章程》第三十七条第一款之規定,選舉委員會現接受第十五屆澳門大學研究生會領導機關候選组別報名,並制定以下指引:

- 一、根據澳門大學研究生會章程中關於選舉之規定以及選舉委員會之要求,報名的 候選組別成員必須具備下述資格:
- 〈一〉、本會會員;
- 〈二〉、具有被選舉權;
- 〈三〉、擁護《澳門大學研究生會章程》;
- 〈四〉、參選閣所有成員必須為澳門大學研究生會2020濠鏡論壇之籌委會成員;
- 〈五〉、參選人(會員大會主席、理事長、監事長)必須具備一定的研會工作經驗,即必須參與原所屬部門主辦活動及兩次或以上本屆籌委會活動(2019新生嘉年華、2019大灣區研究生青年峰會、2020濠鏡論壇)。
- 二、候選組別須同時遞交候選組別成員學生證副本、政綱、宣傳計劃、競選財政預算及宣傳物料樣本(所有文件尺寸均為A4)各一份。
- 三、候選組別將已填妥資料的報名表(報名表請於公告之附件中下載),連同第二點所指資料的所有電子檔在4月23日24:00前電郵至umpa.electbd@um.edu.mo,逾時恕不受理。郵件標題應註明:「第十五屆澳門大學研究生會領導機關選舉一會員大會及理事會選舉報名參選」或「第十五屆澳門大學研究生會領導機關選舉一監事會選舉報名參選」。未在規定期間內報名的參選閣則視為放棄參選資格。
- 四、「可接納的候選組別」經選委會的批准後,可以對其宣傳計劃或宣傳物料樣本作出修訂或增加,但須告知選舉委員會備案。

> University of Macau Postgraduate Association Notice for Election Committee No. 1/2020

Registration as the Candidates of 15th UMPA Leaders

According to Paragraph 1, Article 37 of the University of Macau Postgraduate Association (UMPA) Constitution, the Election Committee starts to accept the application of candidates as the leaders of the 15th UMPA. The candidates must be eligible as the followings:

- 1. According to the related rules in the UMPA Constitution and Election Committee, the candidates for the cabinets should fulfill the following requirements:
- (1) Members of the UMPA;
- (2) Eligible to be elected;
- (3) Upholding the UMPA Constitution;
- (4) All the members of the candidates must be the members of the Preparatory Committee of Hou Keang Symposium.
- (5) The key members of the candidates (President of the General Assembly, Director General of the Board of Directors, Supervisor) must have some working experience in the association. They must have participated in the activities organized by their respective departments, and participated at least two activities organized by the committees this year (2019 New Students Welcome Carnival, 2019 Greater Bay Area Postgraduate Youth Summit, 2020 Hou Keang Symposium).
- 2. Each candidates should submit the political platform, an introduction of promotion, budget, sample of promotion materials, and student card copies of the members (all in A4 size).
- 3. The candidates should submit the application form with the necessary documents, which are required as the above to umpa.electbd@um.edu.mo before 24:00 April 23th. Please remark the following as the subject of the email "The application of candidates to the 15th Management Board of UMPA Election of General Assembly and Board of Directors" or "The application of candidates to the 15th Management Board of UMPA Election of Supervisory Board". Late submission will not be accepted.
- 4. The introduction and samples of promotion of admitted candidates can be revised or increased with the permission of Election Committee. The Election Committee must be informed to put on records for reference.
