2020年第8屆澳門國際創新發明展 (線上) 比賽章程

The 8th Macao International Innovation and Invention Expo 2020 (Online) Regulations

一、目的:

為配合國家"十三五規劃"、"一帶一路"和"粵港澳大灣區"之建設部署,通過搭建本澳與國際創新發明的交流平台和國際青少年、企業之創新發明作品互相交流與分享,藉此推廣科普知識,促進科學技術的進步與發展,開拓更廣闊的前景。

本會已舉辦了7屆的澳門國際創新發明展,惟今年受新冠肺炎疫情影響,將不設場地展覽,改以線上遠程模式進行比賽,並會在澳門科學館舉行頒獎典禮,歡迎出席共襄盛會。

1. Purpose:

In response to the guidelines given in the China's Thirteenth Five-Year Plan, the Guangdong-Hong Kong-Macao Greater Bay Area and The Belt and Road Initiative, Macau International Innovation and Invention Expo is intended to develop a platform for entrepreneurs and teenagers from all over the world to introduce and share their brilliant inventions as well as exchanging the advancement and application of science and technology in different relative fields.

Macao International Innovation and Invention Exhibition has successfully held for 7 years in Macau; however, with the challenge of the COVID-19 pandemic, the 8th Macao International Innovation Invention Exhibition (MiiEX) will only be conducted online. An award ceremony will be held at the Macao Science Center. All of you are welcomed to attend the grand event.

4. Registration and online registration procedures:

五、 參賽資格:

- (一)企業、個人及學生均可報名參賽;分為學生組和企業/個人兩個組別;
- (二)提交近1年(2019年1月1日以後)完成的具有新穎性、科學性和實用性的發明作品;具有創新性、先進性、啟迪性的創意作品;
- (三) 曾參加過本會歷屆發明展的作品不再能參賽(在原有基礎上進行創新及改進的作品除外);
- (四)不接受科學研究論文類作品參賽。

5. Eligibility:

- (1) Individuals, enterprises and students are welcomed to sign up for the competition in the two participation categories, the Enterprise/Individual category and the Students Categories.
- (2) Innovative, advanced, scientific and practical inventions completed within the past year (after 1/1/2019);
- (3) Exhibits that have participated in any previous MiiEX exhibitions are not qualified for registration (except those with obvious and distinct improvement);
- (4) Scientific research papers cannot be registered for this Expo.

六、 視頻提交的要求:

- (一)請將視頻放在如 YouTube、One drive、騰訊視頻、嗶哩嗶哩視頻等專用視頻上載網站,並將視頻連結複製貼上在線上註冊的相關位置;
- (二)請將視頻的觀看權限設定為"公開";
- (三)視頻時間: 2至3分鐘內。視頻中必須包括但不限於作品創作過程、創新發明作品之特點、創造力、作品的實際可操作性及可行的市場化和收益。

6. Video submission requirements:

- (1) Please upload your introduction videos on video platforms such as YouTube, One Drive, Tencent Video, Youku, Bilibili etc., and provide the video link in the online registration;
- (2) Please set the viewing permission of the video to "public";
- (3) Video duration: Within 2~3 minutes (including the opening and ending of the video), the video should include but not limited to the following content: introduce the creation process of the work, the characteristics of the innovative invention, creativity, marketability/profitability, and operability.

七、提交作品研究報告的要求:

- (一) 需根據評分標準的三個要素:創造力、可銷售性和收益及可操作性來介紹,在一千字內。報告 內最少要有作品正面及左、右兩側或內部結構圖片,如有數據提交更佳;
- (二)第一頁是簡介,而其他頁面可以是作品報告或技術說明。為了讓評審委員進一步瞭解作品的情況,在報告內可以貼上專利證書(如有的話);作品獲獎證書(如有的話,僅限最高獎項的證書;作品其他獲獎歷史情況可以用文字說明);
- (三) 不超過五頁 A4 紙,提交 PDF 格式文檔,圖片有需要時請予壓縮,文檔需小於 3MB。

7. Requirements for research report submission of projects:

- (1) The report should explain thoroughly in the three main aspects as mentioned in the rubrics: creativity, marketability /profitability and operability. The report should be written no more than one thousand words. It is recommended to include diagrams of the front, left and right views or the structure diagram of your project, it will be best if related research or experiment data is provided.
- (2) The first page should be reserved for the introduction, and the other pages should include the contents as mentioned. In order to let the judges know more about the project, the patent certificate (if any) can be posted in the report; any previous award certificate can also be included (if any, only the highest award certificate; other awards history can be listed in words);
- (3) Not to use more than five pages of A4 paper, document should be submitted in PDF format, pictures should be compressed if necessary, and the documents should be less than 3MB.

- (一) 海峽兩岸暨港澳地區的參加者可以選擇用中文或英文來撰寫作品研究報告、視頻及撰寫資料,其他國家及地區的所有參展作品的介紹及評審都必須使用英文;
- (二) 所有獲獎者的獎項將通過國際航空郵件發送,請提供詳細地中文或英文地址及郵編。

8. Exhibitors notices:

- (1) Participants from Cross Straits-Hong Kong-Macao area can complete your research report, videos and demonstrations in either Chinese or English. Overseas Participants must complete your research report, videos and demonstrations in English;
- (2) The awards of all winners will be sent by international airmail. Please provide accurate and detailed address (Chinese or English) and postcode.

十、評分標準

- (一) 大會將根據表二的標準來評審;
- (二) 参賽者的視頻解說佔50%;作品研究報告及報名時提交的作品介紹資料佔50%;
- (三) 我們將邀請 CAI、WIIPA、HKFII、HKIA 和世界的友好組織派出國際評審團為作品進行評審。

10. Evaluation Rubric:

- (1) All participating projects will be reviewed and evaluated according to the rubric given (Table 2);
- (2) Participants' introduction videos take up 50%; poste and project introduction materials submitted in the online registration take up another 50%;
- (3) An International Jury Panel will be invited from CAI, WIIPA, HKFII and HKIA and friendly organizations around the world to review the projects.

十一、獎勵方式:

- (一)分別設:金、銀、銅獎。凡獲得金、銀、銅獎的發明人均獲得相關的獎牌和獎勵證書;
- (二)優秀組織獎:組織 10 件或以上作品參展的單位,獲頒發優秀組織獎;
- (三) 大會特別大獎:按照企業、個人一組和學生一組,在每一組當中各選出六個作品獲得特別大獎,獎項包括:國際環保大獎、國際創新大獎、國際發明大獎、最具市場潛力大獎、粵港澳大灣區大獎及一帶一路大獎;
- (四)如果獲獎者未可親自或派代表出席頒獎典禮領取特別大獎,本會則將通過特快專遞方式寄交, 有關的費用由獲獎者支付(郵費如表三),如涉及其他國家或地區,具體另外報價。

11. Reward methods:

- (1) Qualified innovative invention exhibits will receive relevant medals (Gold, Silver and Bronze) and award certificates;
- (2) Best Organizer Award will be presented to outstanding organizations with more than 10 exhibits;
- (3) Six participants from each of the two participants categories (enterprise/individual and students) with excellent innovation projects will be granted the Grand Award of the General Assembly in their respective innovation categories. Awards in their respective categories includes International Environmental Protection Award, International Innovation Award; International Invention Award, Best Market Potential Award, Guangdong-Hong Kong-Macao Greater Bay Area Award and The Belt and Road Initiative Award;
- (4) All awards will be presented in the Award Presentation Ceremony, if the winner cannot attend the ceremony in person and not able to send a representative, the award will be sent by express mail to the participants address as registered. Noticed that related expenses will have to be paid by the winner. The postal charges are as below Table 3. (countries or regions not in the table will be quoted separately).

- (3) The event organizer (MiiA) has the right to explain and alter the rules and regulations of this expo, use any pictures and videos of all the participating exhibits, participants may not object such policy.
