澳門大學研究生會監事會候選閣 ---規箴閣參選政綱



政綱核心

規箴,原意為勸勉告誠,按規矩辦事不以私情滅道義,出自王安石《與王深父書》:"自與足下別,日思規箴切劘之補,甚於饑渴"。 規箴閣以"有箴必規,有言必察,有疑必究"為工作理念,秉持"規箴為己,規箴為人"的工作態度,盡我們之所能,行監督之責,履諫言之務,以服務學生為根本,與全體澳門大學研究生一同鐵肩擔道義,在砥礪自我中奮發前行。

六項工作重點

監事會,作為三權分立中司法監督的機構,理應遵照章程,依法治理,履行監督之責。本閣認為,監督一職,除了監視、督促理事會日常運作之外,也應做到廣開言路,察納雅言。而對於優化投訴及建議機制,應做到認真聽取,積極討論,及時採納,以澳門大學全體在

讀研究生為立足點,建設一個"從學生中來到學生中去"的研究生會。 "須得互相規箴,互相扶助,藉集體力量來形成一種高尚純潔的風氣"。新一屆監事會將以"有箴必規,有言必察,有疑必究"為理念, 就如何行使監事會的職權,本閣認為工作重心應該分為以下幾個方面:

1. 明確閣內責任, 落實各項決議

本閣將堅持依照《澳門大學研究生會章程》和相關法律條文為基礎和前提,開展相關工作。同時根據研會章程,本閣將服從會員大會與常務委員會的決議,履行監事會應盡的責任與義務,做到閣內思想統一、責任明確、步調一致,確保會員大會與常務委員會的各項決議落實落細。

2. 堅持"有箴必規", 工作公開透明

本閣依據本研會之章程,將履行監督理事會日常運作與財務的合理運用之責任。本閣將圍繞審查本會理事會及附屬組織的運作以及財務支出狀況,開展系列監督工作,堅持"有箴必規"的工作理念,即有意見或問題絕不隱瞞,而是如實上報。尤其在財務方面更應做到事無巨細公開透明,本閣並將依據"開源節流"、"精打細算"、"量入為出"等重要原則,杜絕大手大腳、鋪張浪費、公款私用等一切不正當財務行為。以收支平衡和會員回饋為最終目標、發現問題第一時間對有關

事項提出書面意見並且遞交會員大會嚴肅處理。

3. 堅持"有言必查", 維護會員利益

本閣應受理澳大研究生的意見及建議,並及時向會員大會反映。本閣對這一方面同樣給予高度重視,所以在"有箴必規","有疑必究"之後還有"有言必察"做為工作理念,意為聽取意見時要仔細調查全部意見的前因後果,做到不偏聽,不盲聽。只有這樣才有助於我們掌握第一手資料,瞭解意見背後的真實需求;才有助於我們做出正確的判斷,調整監督工作的方向;才有助於為我們後續深入對照、查擺問題、落實職責打好堅實的基礎。本閣必將秉承公開透明、有言必查的原則,積極、準確並及時地處理各項投訴,做到敢於發現問題、如實報告問題、推動問題的解決,以澳門大學全體在讀研究生為立足點,建設一個"從學生中來到學生中去"的研究生會。

4. 堅持"有疑必究", 牢記服務使命

"有疑必究"指的是對出現的疑點應追究到底。它有兩點內涵,其一是由於監事會和理事會的相互獨立性,導致監事會對於日常工作的監督存在滯後性,但是本閣認為監督工作不能只是一味的做補漏工作,更應是未兩綢繆,因此在形成真正的問題之前也應盡可能提出意見和建議。對此本閣將認真審查每項活動的流程以及預算,防止經費的不正當使用。其二是監事會要時刻保持"獨立性",杜絕監督和被監

督對象的"粘連"現象,如有任何可疑的包庇錯誤、掩蓋問題的現象都應一究到底,真正做到"零容忍"。對此本閣將承諾堅決杜絕監事會成員與研究生會其他成員相互勾結的情況出現。

我們將時刻牢記自己手中的監督權力是全體澳門大學研究生賦 予的,因此維護全體研究生的權益便是我們的使命。堅持"有疑必究" 就是為了堅持在本閣內部形成一種嚴謹認真、剛正不阿的工作作風。

5. 堅持工作創新. 優化維權機制

完善日常監督工作,積極優化維權機制,推進維渠道的"扁平化" 革新。所謂"扁平化",一方面應保證維權機制的多措並舉;另一方面 應簡化維權過程,以監事會工作效率最大化為目標,依據研會自身條 件,讓研究生的維權能一步到位。本閣將及時收集、聽取、調研有關 廣大同學切身利益和普遍訴求的問題,並以報告形式反饋給各級部 門,切實推動問題的解決。

堅持工作創新,本閣認為應該充分運用"新媒體平臺"來作為監督 陣地,通過搭建網絡意見收集平臺,實現更爲快捷高效的信息雙向傳 遞,既讓研究生的維權更簡單直接,也讓維權的反饋更公開透明。此 外,還應緊跟時代潮流,充分發揮網絡平臺的監督作用,監督相關輿 論,進一步加強通過網絡平臺服務研究生的力度,增強工作互動性, 接受廣大研究生的監督和評議。

6. 堅持正人正己,完善自身建設

正所謂"打鐵還須自身硬",本閣認為監督首先應做到正人正己。

本閣將對內部成員高標準嚴要求,進一步完善自身內部建設,提升本閣成員間的凝聚力,強化對自身思想道德素質、科學文化素質、綜合能力素質和文化修養素質建設,堅持成為有理想、有追求、有擔當、有作為、有品質、有修養的"六有青年"。堅持正人正已,符合本閣所秉持的"規箴為己,規箴為人"的工作態度,有助於提升本閣成員的領導力、服務力和工作覆蓋力。

本閣將時刻秉持公平公正的態度,不忘初心,繼續維護澳門大學全體研究生的利益。我們將認真審查每一份報告,認真聽取每一位同學的意見,在傾聽和反思中總結經驗,通過實踐摸索出一條更高效的道路,將監事會建設為更加完善的部門。

The Core Principle of Our Service

The Kwai Zam Cabinet promises to serve the graduate students to the best of our abilities. We have decided that "Impartial Advice for Everyone" shall be the our core principle of our service, if the UM graduate students given us the opportunity to serve. We promise to put the graduate students first, and to move forward alongside with them.

The Goals of Our Service

As the Judicial Branch of the University of Macau Postgraduate Association (UMPA), the Supervisory Board shall serve according to the UMPA Constitution, as well as the applicable regulations. The Kwai Zam

Cabinet, therefore, shall perform the duty of supervision based on these policies. In addition, the Kwai Zam Cabinet believes that our responsibility shall go beyond supervising the regular operation the UMPA Board of Directors. We shall also be the Supervisory Board which listens to the graduate students. The Kwai Zam Cabinet, therefore, propose to simplify the channels for graduate students to submit their comments and suggestions to us, so that the graduate students' voices will be heard and considered by UMPA. We promise to establish a Supervisory Board that is of, for, and by the graduate students. The goals of our service are as follows:

1. To Clarify Our Responsibility and to Deliver the Decisions

First, the UMPA Constitution and the applicable regulations are the primary bases and premises for our service. According to the UMPA Constitution, we shall deliver the decisions made by the General Assembly and the UMPA Standing Committee. Thus, the Kwai Zam Cabinet shall fulfill the responsibility and obligation of the Supervisory Board as stated to our best ability.

2. To Uphold the Principles, and to Ensure Transparency in our Service

According to the UMPA Constitution, the Supervisory Board shall oversee the operation and financial spending of the Board of Directors,

and its affiliated organizations. The Kwai Zam Cabinet promise, after reviewing the proposed budgets to our best ability, they shall all: be balanced, in terms of revenue and spending; be effectively spent, and; have no wasteful spending. Shall we discover any illegal and/or improper financial spending our own; or receive any comment from UMPA members regarding the Association's fiscal matter, we promise to seriously and carefully investigate the incident, and submit our written report to the General Assembly afterwards.

3. To Safeguard UMPA Members' Interests

The Board of Supervisors shall handle comments and suggestions from UM graduate students, and give feedback to the General Assembly on a timely base. The Kwai Zam Cabinet highly values such aspect. Since "Impartial Advice for Everyone", is the core principle of our service, we shall investigate any given matter in a professional and ethical manner. We believe that only in this method, we can learn the whole truth of an incident, and then provide our impartial advice to those who needed.

4. Remembering Our Duty at All Times

Our duty is to supervise the Board of Directors. We shall oversee the Board of Directors in two aspects. One, we shall not only solve a problem after it causes harm. The Kwai Zam Cabinet believes that we shall take care of an given issue before it damages UMPA. Thus, we shall seriously

and carefully review every single proposed budget, to ensure all funds are used in a legal and proper manner. Second, we shall distance ourselves from the Board of Directors and its affiliated organizations, shall any one of them becomes our investigative subject. Thus, the Kwai Zam Cabinet promises to remain impartial in any given investigation.

We shall remember at all times, it is the graduate students of UM, who give us the right to serve them. Thus, shall we be elected, our deepest responsibility is to protect their interests.

5. To Introduce a New and Simple Method for UM Graduate Students to Protect Their Rights

Shall we be given the privilege to serve UM graduate students, we are going to bring a change to UMPA. The Kwai Zam Cabinet shall introduce a new and simple method for UM graduate students to submit their comments and suggestions to the Supervisory Board. By doing so, the graduate students' concerns can be solved in a timely manner.

Shall we be elected, we are going to create an online platform for UM graduate students to tell us the issues that they worry about. We believe that this new and simple channel can be even more effective for UM graduate students to communicate with UMPA. The Kwai Zam Cabinet shall closely monitor the online platform to ensure that comments and suggestions that are posted there be handle as impartial as those

submitted to us offline.

6. Holding Ourselves to High Ethical Standards

Shall we be elected, we will hold ourselves to high ethical standards. The Kwai Zam Cabinet shall always remind ourselves that we are obligated to provide "Impartial Advice for Everyone", and to protect the UM graduate students' interests to the best of our ability.

Our Pledge

The Kwai Zam Cabinet shall always remember that our core principle of our service is "Impartial Advice for Everyone". We shall do our best to protect the rights and interests of UM graduate students. We shall vet every single budget proposal, activity report seriously and carefully. We shall handle the comments and suggestions of UM graduate students in a professional and ethical manner.

This campaign platform is our contract with all the UM graduate students. We hereby make this pledge to UM, the Election Committee, and all the UM graduate students: we shall act impartially, if we are given the chance to serve.
